ATTENDED FUNERAL (funeral director's charges only) This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	£2713
Taking care of all necessary legal and administrative arrangements	£1398
Collecting and transporting the deceased person from the place of death (within 20 miles of the funeral director's premises during office hours) into the funeral director's care	£200
