

ATTENDED FUNERAL (funeral director's charges only) <i>This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.</i>	£2713
Taking care of all necessary legal and administrative arrangements	£1398
Collecting and transporting the deceased person from the place of death (within 20 miles of the funeral director's premises during office hours) into the funeral director's care	£200
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at our premises located at The Square, High Street, Banchory.	£250
Providing a suitable coffin – this will be made from light wood effect veneer	£615
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer) (out of hours only)	£30
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (within 20 miles of the funeral director's premises)	£250

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

Burial (Funeral Director's charges only)	Not offered
Cremation (Funeral Director's charges including the cremation fee)	£1895

FEES YOU MUST PAY

For an Attended or Unattended burial funeral, the burial fee . ¹	£1133
In this local area, the typical cost of the burial fee for local residents is:	£1133
<i>For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.</i>	
For an Attended cremation funeral, the cremation fee . ² In this local area, the typical cost of a cremation for local residents is:	£880

ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:

Additional mileage (price per mile)	Prices on request
Additional transfers of the deceased person's body (e.g. to their home, to a place of worship etc.) (price per transfer)	Prices on request
Collection and delivery of ashes	Prices on request
Embalming	From £140
Funeral officiant (e.g. celebrant, minister of religion etc.)	Prices on request
Services supplied outside of normal office hours	From £30

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.
